1983 JEEP SCRAMBLER CJ-8

I bought this '83 Scrambler in 1996 in stock condition and have been slowly modifying it ever since. Some of the modifications include ARB air lockers in both axles with 4:56 gears, 33" BFG Mud Terrain tires, 4" Superlift, full custom roll cage with Beard racing seats for 6 people.

The motor is stock with the exception of a Mopar multi-port fuel injection system which is my favorite modification. The exterior was freshened up with '02 Jeep Liberty Cactus Green paint applied by Jirah Restorations of Prescott.

We have taken our Scrambler over such notable trails as the Terminator's here in Arizona, the Golden Spike in Utah and the Rubicon in California. 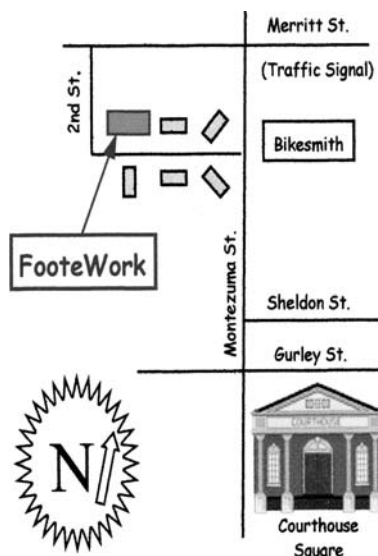

Or, And, And/Or - What does that mean on my title?

Did you know there's more than one way to own a vehicle?

When more than one person owns a car, there are three different ownership options. Each option directly affects what needs to happen to sell or perform any other MVD function for that vehicle.

How do you know which option you have? Look at the word between your names, usually found at the right side of your title.

1) If it's an Or - John Doe OR Joe Ross - then the ownership is joint tenancy with an expressed intent that either of the owners has full authority to transfer ownership of the vehicle, license plates and/or fees or to record loan information. To transfer ownership of the vehicle, license plates and/or fees to record loan information, the signature of either party will be accepted. Both signatures are not required. If you choose this legal status, then only one owner must sign in the Legal Status section. **This legal status is recommended for most situations.**

2) If it's an And - John Doe AND Joe Ross - then this ownership is a tenancy in common. To transfer ownership of the vehicle, license plates and/or fees or to record loan information, then signatures of both parties will be required. In the event of the death of either party, the interest of the deceased party must be handled by probate action or by completing a non-probate Affidavit. This is used mostly for legal entities, not for the general use of the public.

2) If it's a And/Or - John Doe AND/OR Joe Ross, then this is a joint tenancy with right of survivorship. To transfer ownership of this vehicle, license plates and/or fees or to record loan information, the signatures of both parties will be required if both are living. Upon proof of death, the survivor may sign alone. This is the most confusing entity. It looks like you have a choice of AND or OR, but that isn't true. It's deceiving because it still requires both parties to sign for any function of that vehicle.
